In addition to meeting the requirements of the CAA and containing measures needed to attain the NAAQS as expeditiously as practicable, the SIP includes the latest technical information, including emissions inventory, monitoring data, and computer modeling results. The Plan is divided into several chapters, with supporting documents provided as appendices. The District developed the Plan with an extensive public process, including workshops and draft documents provided by the District in April, June, and October of 2012.

The Project will replace the existing Sheriff's Tower dock with a new aluminum dock of approximately 253 feet by 48 feet in size that will accommodate 24 vessels. The new dock is the same size and accommodates the same number of vessels as the existing dock. The existing dock will be disassembled and removed from the Project site, and four new 4-inch galvanized steel piles will be driven into the lakebed to provide anchor points at the end of the new dock. The new dock will be installed and secured to existing anchor points near the lake shore and to the new anchor points in the lakebed.
