Add Chapter 2 (Sections 16100 et seq.) to Division 6.3 of Title 14 of the California Code of Regulations as follows:

Chapter 2. Regulations Governing Applicant Fees for Environmental Leadership Project Applications

§ 16100. Fees

The fee for filing an application for streamlining certification pursuant to Chapter 6.5 of Division 13 of the Public Resources Code is thirty-nine thousand dollars (\$39,000). As of the effective date of this chapter, all applicants must pay this fee in order to be eligible for certification.

§ 16101. Submission of Fees

(a) The application fee for each application is due at the time of filing the application with the Office of Planning and Research.

(b) Application fees must be submitted by a check made out to the Office of Planning and Research. Application fees must be submitted to 1400 10th St. Sacramento CA, 95814 in person or via certified mail.

(c) Applicants must include the following information alongside submission of their application fee:

_____ (1) The applicant name;

_____ (2) The name of project the applicant is seeking certification for; and

(3) A statement that the enclosed check is the application fee for the applicant's Environmental Leadership Project Application and that OPR is authorized to process the check.

(d) Proof that the application fee has been mailed at the time an applicant submits their application shall be sufficient for the Office of Planning and Research to begin reviewing the application. The application fee must be received and processed prior to certification by the Governor.

§ 16102. Exemption for Certain Housing Project Applicants

Housing development project applicants that meet the criteria set forth at Section 21180, subdivision (b)(4) of the Public Resources Code, are exempt from the fee set forth in section 16101 of this chapter.
