Introduction

The State Clearinghouse (SCH) within the Governor's Office of Planning and Research (OPR) serves as California's Single Point of Contact for the <u>Intergovernmental Review of Federal Programs</u> pursuant to <u>Presidential Executive Order No.</u> <u>12372</u>. The SCH is also designated by <u>Assembly Bill 1348</u> (Irwin, Chapter 444, Statutes of 2016) to provide information on federal grant opportunities to maximize the state's ability to pursue and manage federal grant funds. To support that goal, this guidebook was developed to share concise information on an extensive selection of federal assistance programs available to people and organizations across California. Additional information on federal grant opportunities, grant management, and other resources is provided on the <u>OPR Federal Assistance webpage</u> to assist organizations in obtaining and managing federal grants.

This guidebook lists over 800 federal grant programs available to individuals, governments, and all types of organizations to help address some of the biggest issues facing our state and country. The grant programs are organized by a series of eleven topic areas, which are derived from the 20 basic "functional categories" identified by the Annual Publication of Assistance Listings (APAL) published by the federal General Services Administration (GSA). Each grant is grouped into the category that most fits its primary purpose, although may relate to multiple topics.

Each grant program is identified by a five digit Catalog of Federal Domestic Assistance (CFDA) Assistance Listing number. The first two digits identify the federal agency responsible for the grant. In this report, the hyperlink embedded in the CFDA number directs to a <u>grants.gov</u> search for all open opportunities for that grant program. Grants.gov offers the opportunity to subscribe to receive notifications for new opportunities matching saved search criteria. In limited cases where the grant program is not advertised on grants.gov, then the hyperlink directs to the appropriate agency or program website.

The grants listed are those more relevant to California, and so programs focused on other states, insular areas, or foreign nations are excluded. Many specialized medical research grants are excluded, as are many programs eligible for sole source applicants. In most cases, formula, block, and other grant opportunities only available to State agencies were excluded, with the exception of some programs that offer subawards to local entities.
